Script for samples will be sold for \$1.00 each. Samples are not to be sold for more than \$3.

Terms & Conditions:

Exhibitor, for itself, it's directors, officers, employees, agents representatives, servants, licenses, invitees, patrons, guests, or contactors and their personal representatives, assigns, heirs and next of kin (herein referred to as "Exhibitor" hereby releases, waives, discharges and covenants not to sue the City of North Bend & The Mill Casino, The Coquille Indian Tribe, CEDCO, it's directors, officers, employees, agents, representatives, servants, licensees, invitees, patrons, guests or therefore on account of injury to the person or property or resulting death of Exhibitor arising out of or relating to the BBQ, Blues & Brews on the Bay, whether caused by the negligence of the Releases or otherwise.

Releasees may incur from any and a claims, demands, actions, causes of actions, penalties, judgments, and liabilities of every kind and description (including court costs and reasonable attorneys fees) for injury to or any death of persons and damage to and loss of property which are caused by, arise from or grow out of the acts or omissions of Exhibitor incident to The Mill Casino or from any breach by Exhibitor of any term or condition of the agreement. Exhibitor hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the BBQ, Blues & Brews on the Bay, whether caused by the negligence of the Releasees or otherwise.

Exhibitor hereby agrees that this Release and Waiver, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees and is intended to be as broad and inclusive as is permitted by the laws of the State of Oregon and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. We, the undersigned, do hereby apply for the reservation of exhibit space in the BBQ, Blues & Brews on the Bay event, May 26-27, 2018.

When executed by both parties to this agreement, this shall constitute a binding agreement between the parties wherein Mill Casino & BBBOTB Committee agrees to rent the undersigned exhibitor and the undersigned exhibitor agrees to rent Mill Casino & BBBOTB Committee the exhibit space at the location as more fully described in the first section of this agreement

We understand that this agreement shall be legally binding between Mill Casino & BBBOTB Committee and the exhibitor upon acceptance in writing by the Mill Casino & BBBOTB Committee. We understand that any change in the information on this agreement must be made in writing.



Service: BBBOTB Committee agrees to provide the exhibitor named above (the “Exhibitor”) area space

Fees. Exhibitor shall pay the total fees set forth to Producer upon Registration. All amounts due to Producer under the agreement are unconditional obligations of Exhibitor and shall be paid to Producer as described herein and are nonrefundable

Cancellation Policy. Deposits are non-refundable.

Media Release. I hereby grant to The Mill Casino * Hotel the right to use and publish my name/likeness, audio, video, print and film recordings in which I may be included for editorial trade, advertising, promotion or other commercial purposes. I waive any right to inspect or approve the finished product, advertising or other copy and to all phases of its use in whatever form to be determined by The Mill Casino * Hotel and its entities. It is understood that no compensation will be paid by The Mill Casino * Hotel for the right to the photo or reuse the audio, video, print and film recordings for promotional purposes.

Termination of Exposition. At sole determination of Event Management, in the event that premises where the event is to be held becomes unfit for occupancy or are substantially interfered with the Agreement may be terminated by Event Management. Such reasons for termination my include, but are not limited to, picketing, strike, embargo, injunction, act of war, act of God, fire, emergency declared by any governmental agency. Event Management no longer operation as a business, by virtue of any ordinance or law of any municipal or governmental agency or any other act beyond the control of Event Management. In the event of such termination, the exhibitor hereby waives any and all damages and agrees that Event Management shall, after deduction all cost and expenses relating to the Mill Casino & BBBOTB Committee including a reserve for claims and demands related to said event, refund its prorata remaining amount of all funds paid by all exhibitors.

Food Sales & Samples. Samples of food or beverage are governed strictly. Exhibitors must comply with all governmental regulations, laws and ordinances. Food sales are prohibited at this event with the exception of the Vendors. Script will be sold for \$1.00 per 2 oz. sample. Script will be sold by the BBBOTB Committee. Earnings will be split 75/25 at the conclusion of the event.

Liability. Producer’s liability is limited to the actual money paid by the Exhibitor to Producer hereunder. Exhibitor agrees to obtain liability insurance for its rental space and property used in the show. Exhibitor is responsible for any liability arising out of its participation in the show, including product liability accident or injury, and hereby agrees to indemnify Exhibitor for and hold Exhibitor harmless from the same. If Exhibitor does not stay within the boundaries of its booth, Producer may remove Exhibitor immediately from the event. Exhibitor will forfeit any money paid and any amount still due.

Exhibit Restrictions. No exhibitor will be permitted to erect signs or display products that obstruct the view, are unsafe or disadvantageously affect the display workmanlike and neat manner – when they may be viewed from aisles or from any adjoining exhibit space. All exhibits and exhibitor personnel must remain and dispense materials within the confines of their own exhibit space.

Entire Agreement. This written agreement represents all understandings between Producer and Exhibitor and no oral representations have been relied on that are not written on this form. All changes to this agreement must be written and signed by the Producer.

Valid Contract. This agreement is not binding upon to the Mill Casino & BBBOTB Committee until it has been accepted and signed by its authorized signer from The Mill Casino.

Indemnification: Client agrees to indemnify and hold The Coquille Indian Tribe, The Coquille Tribal Gaming Commission, Coquille Economic Development Corporation, it’s operating entities and wholly owned subsidiaries harmless from all claims, losses, expenses, fees including attorney fees, costs, and judgments that may be asserted against the above mentioned that result from the acts or omissions of the Client and the Client’s representative or members.
